BOOK FAIR: we didn't make any cash profits but made some scholastic credits.

SPIRIT WEAR: sales are going well and Tracey ordered more adult sizes because we ran out. We plan to sell on Thursday night at the PeeWee basketball/cheer meeting.

PARAGON fundraiser began today and will run to September 24. The Mega Party will be on November 30. 30-minute Sky Zone passes from Fairview Heights will be provided as an incentive.

ASSEMBLY: Sarah Mills provided information from Klein Orthodontics for an October assembly. Since it will be National Orthodontic Health month, Klein Orthodontics will bring a Smile Squad to give interactive educational presentations on the importance of oral health and overall healthy habits.

However, since the dumpster did not appear to be specifically ordered just for PTO use, the board elected to not pay the bill and have Tracey Starr turn the bill in to Kyla Beaver to pay from the school funds.

It has been made aware to us that the teacher/student Crisis bags are out of date and low in number. We recommended that the Student Council look at this issue and continue these Crisis bags as they have in the past.

The board reviewed 2 Teacher and Staff PTO Questionnaire forms that were turned in for feedback on how the PTO helps the classes and to make the PTO better. The teachers would like for us to contribute financially to their classroom needs but due to the number of teachers we now have, it drains the account too quickly to give a worthy amount to make a difference.

Discussion was made concerning a new Globe for the library as the current Globe is out of date. Sarah Rupe motioned to spend \$400 for a new one; Sarah Mills seconded.

Sarah Rupe drew from the names that were put in the bucket at the Open House for the Paragon basket. The winner is Lori Kell. Sarah to notify Lori to pick up the basket at the main office.
